## **WORK GROUPS**

- **Internship**
  - Susan Allen reported that Martha Younger-White was unable to join the ICED meeting today, but provided information about the Internship work group. One Summer Chicago placements were made at DHS and Corrections. The individual referred to Guardianship and Advocacy never arrived for the placement. Karen Tamley of the Mayor's Office for People with Disabilities said that nearly 60 placements were made this summer through One Summer Chicago for students with disabilities. They want to expand to even more placements next year. Martha Younger-White will develop a page about internships on the new ICED website, and she is planning a workgroup meeting prior to the October ICED meeting.
  - Alicia Rentmeister asked whether there are many internship opportunities involving general clerical duties/skills, and Susan said there are two titles for students, Student

Worker and Student Intern. The Student Worker title often involves clerical or administrative

### **Styles of Mentoring:**

- ✓ One on One Mentoring - requires more time- trust building
- ✓ Peer Mentoring - common goals
- ✓ Virtual Mentoring - electronics-still some face to face but reduced
- ✓ Group Mentoring - less personal, multi-directional

- Some discussion of mentoring followed, and it was decided a work group should be formed to study the issue and make recommendations at to ICED's role in mentoring of state employees with disabilities. There is currently no disability Mentoring Program or any formal mentoring program in state government. Susan asked for volunteers for the mentoring program work group. Susan, Tania, Debbie Johnson-Small, Anna D'Ascenzo, and Alice Minter agreed to join the work group.
